REPORT OF THE DIRECTORS,

WITH STATEMENT OF ACCOUNTS ANNEXED

To be presented at the ORDINARY GENERAL MEETING of the Shareholders, to be held at Southern House, Cannon Street, London, E.C. 4, on Thursday, the 10th day of December, 1936, at 2.30 o'clock.

The Directors have to report that, after payment of all charges and after making provision for Income Tax and for Bad and Doubtful Debts and Contingencies, the net profit for the year ended 30th September, 1936, amounted to the sum of £401,191 17s. 4d., to which has to be added the sum of £223,396 15s. 3d. brought forward from 30th September, 1935, making a total of £624,588 12s. 7d.
