<b>Finance Charge Receivables</b>	"Finance Charge Receivables" are amounts owing from cardholders for transaction fees, Periodic Finance Charges, special fees and annual fees and any Interchange and Discount Option Receivables.  Capitalised terms "Periodic Finance Charges", "Interchange" and "Discount Option Receivables" are defined as per the current Base Prospectus.
<b>Total Receivables</b>	"Total Receivables" are the sum of "Principal Receivables" and "Finance Charge Receivables".
