This prospectus supplement dated 12 May 2017 (the "**Prospectus Supplement**") is supplemental to, and must be read in conjunction with, each of the base prospectuses listed in the Schedule hereto (each such base prospectus, as supplemented by the (i) Combined Supplement 1/2016 dated 23 August 2016 (save for Base Prospectus 1), (ii) Combined Supplement 2/2016 dated 25 November 2016, (iii) Combined Supplement 3/2016 dated 21 December 2016, (iv) Combined Supplement 4/2016 dated 12 January 2017 and (v) Combined Supplement 5/2016 dated 16 March 2017, a "**Base Prospectus**" and together, the "**Base Prospectuses**") as prepared by Barclays Bank PLC in its capacity as issuer (the "**Issuer**") in respect of its Global Structured Securities Programme (the "**Programme**"). This Prospectus Supplement constitutes a base prospectus supplement in respect of each Base Prospectus for the purposes of Directive 2003/71/EC (and amendments thereto) and Section 87G of the UK Financial Services and Markets Act 2000 ("**FSMA**").

Terms defined in the Base Prospectuses shall, unless the context otherwise requires, have the same meanings when used in the Prospectus Supplement.

The purpose of this Prospectus Supplement is to amend and supplement certain information in the "Summary", "Information Incorporated by Reference" and "General Information" sections of each Base Prospectus due to the release of the Q1 2017 Results Announcement, the April Announcement and Supplement 6/2016 to the Registration Document (as defined below).
