#### What are the key risks that are specific to the Issuer?

The Securities will be issued in Euro ("EUR") (the "Issue Currency") and settled in the same currency (the "Settlement Currency"). The Securities are tradable in nominal and the specified denomination per Security is EUR 1,000. The issue size is EUR 2,600,000. The issue price is 100% of the Specified Denomination.
