This base prospectus supplement (the "**Supplement**") is supplemental to, forms part of and must be read in conjunction with, the base prospectus dated 19 June 2023 (the "**Base Prospectus**") prepared by Barclays Bank PLC (the "**Issuer**") with respect to its Debt Issuance Programme (the "**Programme**"). This Supplement constitutes a supplementary prospectus in respect of the Base Prospectus for the Issuer for the purposes of Article 23 of Regulation (EU) 2017/1129 of the European Parliament and of the Council of 14 June 2017 as it forms part of domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018, as amended (the "**UK Prospectus Regulation**").

Terms defined in the Base Prospectus shall, unless the context otherwise requires, have the same meaning when used in this Supplement.

This Supplement has been approved by the United Kingdom Financial Conduct Authority (the "**FCA**"), as competent authority under the UK Prospectus Regulation. The FCA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer that is the subject of this Supplement. With effect from the date of this Supplement the information appearing in, or incorporated by reference into, the Base Prospectus shall be supplemented in the manner described below.

The purpose of this Supplement is to:

- (a) supplement the information set out in the section entitled "*Information Incorporated by Reference*" commencing on page 14 of the Base Prospectus, and additionally incorporate by reference into the Base Prospectus:

- (b) amend the second paragraph of the section entitled "*Forward-Looking Statements*" commencing on page vii of the Base Prospectus by replacing the phrase "conflict in Ukraine" with the phrase "Russia-Ukraine war";
- (c) replace the third paragraph of information in the section entitled "*Forward-Looking Statements*" commencing on page vii of the Base Prospectus with the following updated information:

"Additional risks and factors which may impact the Barclays Bank Group's future financial condition and performance are identified in the Issuer's filings with the SEC (including, without limitation, the Issuer's Annual Report on Form 20-F for the fiscal year ended 31 December 2022, and Interim Results Announcement for the six months ended 30 June 2023 filed on Form 6-K (as defined in "*Information Incorporated by Reference*" below)), which are available on the SEC's website at www.sec.gov.";

(d) amend the sub-section entitled "*Risk Factors - Risks relating to the Issuer and the Barclays Bank Group*" on page 6 of the Base Prospectus by deleting it in its entirety and replacing it with the following:

(e) amend the section entitled "*The Issuer, the Barclays Bank Group and the Group*" on page 109 of the Base Prospectus by deleting it in its entirety (including the "*Recent Developments*" sub-section thereunder) and replacing it with the following:
