The Group's businesses include consumer banking and payments operations around the world, as well as a global corporate and investment bank. #### What are the key risks that are specific to the Issuer?

The Barclays Bank Group has identified a broad range of risks to which its businesses are exposed. Material risks are those to which senior management pay particular attention and which could cause the delivery of the Barclays Bank Group's strategy, results of operations, financial condition and/or prospects to differ materially from expectations. Emerging risks are those which have unknown components, the impact of which could crystallise over a longer time period. and evolving nature of the Barclays Bank Group's businesses and business practices.
