In response to the ongoing Covid-19 situation in the UK, the FCA confirmed on 9 April 2020 that credit card customers who are impacted financially by Covid-19 should be offered a payment deferral for up to three months. Where customers have made a successful application, unless such customers were already in forbearance, they are not considered to be in a payment shortfall and therefore any such missed payments will not be considered as arrears for the purposes of investor reporting. Neither will they be reported as having been subject to any form of restructuring or forbearance due to such Covid-19 payment holiday alone. On 22 May 2020, the Issuer gave notice to Noteholders of the exercise by the Transferor of the Discount Percentage in relation to certain Principal Receivables forming part of the Gracechurch Receivables Trust, such that, on and from 15 June 2020, 5% of those Principal Receivables will be characterised as Finance Charge Receivables. In response to the FCA announcement on 9 April 2020 that credit card customers who are impacted financially by Covid-19 should be offered a payment deferral for up to three months, the accumulation of Series 2018-1 was accelerated ahead of its scheduled redemption in July 2020. As a consequence of the accelerated accumulation, the floating and fixed investor percentage of Series 2018-1 reduced to 0% in May 2020 resulting in 0% being reported for Portfolio Yield. Expenses on the Series 2018-1 finance charge waterfall are being met from available funds generated by the withdrawal of the re-investment account proceeds relating to the Series on principal redemption.
